THE TWELVE TRADITIONS

- Our common welfare should come first; personal recovery depends upon A.A. unity.
- 2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants: they do not govern.
- 3. The only requirement for A.A. membership is a desire to stop drinking.
- Each group should be autonomous except in matters affecting other groups or A.A. as a whole.
- 5. Each group has but one primary purpose—to carry its message to the alcoholic who still suffers.
- 6. An A.A. group ought never endorse, finance, or lend the A.A. name to any related facility or outside enterprise, lest problems of money, property, and prestige divert us from our primary purpose.
- Every A.A. group ought to be fully self-supporting, declining outside contributions.
- Alcoholics Anonymous should remain forever nonprofessional, but our service centers may employ special workers.
- A.A., as such, ought never be organized; but we may create service boards or committees directly responsible to those they serve.
- Alcoholics Anonymous has no opinion on outside issues; hence the A.A. name ought never be drawn into public controversy.
- 11. Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio, and films.
- 12. Anonymity is the spiritual foundation of all our traditions, ever reminding us to place principles before personalities.

The Twelve Concepts for World Service


- Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowshia.
- The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- To insure effective leadership, we should endow each element of A.A. the Conference, the General Service Board and its service corporations, staffs, committees, and executives - with a traditional "Right of Decision."
- At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in reasonable proportion to the responsibility that each must discharge.
- Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference action as the General Service Board.
- 7. The Charter and Bylows of the General Service Board are legal instruments empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon tradition and the A.A. purse for final effectiveness.
- The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- 11. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- 2. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.













THE PATH FOR AN IDEA TO BECOME AN AGENDA ITEM

1	An idea, suggestion, question, concern or subject comes from an A.A. member, GSR, DCM, area committee member, delegate, trustee, or G.S.O./GV staff, and may be shared or discussed at the group, district and area assembly and sent to the	Conference Coordinator G.S.O.
2	The idea is reviewed by the G.S.O./GV Staff and forwarded to the	Appropriate Trustees' Committee
3	which then may refer the matter to the	Appropriate Conference Committee
4	which meets during the General Service Conference week and makes recommendations that are presented in the Committee Report to the	General Service Conference
5	If a Conference Committee recommendation is approved, after full floor discussion, it becomes a Conference Advisory Action, which becomes binding when approved by the	General Service Board





How the Conference Operates

enerally speaking, the General Service Conference follows Robert's Rules of Order, and proceeds on as informal a basis as possible consistent with the rights of all concerned. It is important to remember that the purpose of rules of order is to make it easier for the Conference to conduct its business; rules exist to allow the Conference to do what it needs to do to carry out the will of the Fellowship by reaching an informed group conscience. Over the years the Conference has adopted some exceptions to Robert's Rules, which help it to proceed more closely in accord with the spirit of A.A. Tradition.

Conference Quorum

A Conference quorum — two-thirds of all registered members — is required to conduct Conference business.

Committee System

To the extent possible, important matters to come before the Conference will be handled via the "Committee system." This assures that a large number of questions can be dealt with during Conference week. Members are encouraged to trust the process. Each Committee has considered carefully the items before it and presents its recommendations to the Conference as a whole for acceptance or rejection. Recommendations of Conference committees are automatically motions that have been made and seconded. Members are asked to refrain from spontaneously amending the work of the Committee; there are no "friendly" amendments under Robert's Rules.

Substantial Unanimity

All matters of policy (Conference Advisory Actions) require substantial unanimity, that is, a two-thirds majority. Any actions, including amendments, that affect an Advisory Action, or motions that might result in such an action, also require a two-thirds majority. Because the number of members present in the hall during the week of Conference varies from time to time, the phrase "two-thirds majority" is taken to mean two-thirds vote of the Conference members voting, as long as the total vote constitutes a Conference quorum.

Minority Opinion

After each vote on a matter of policy, the side which did not prevail will always be given an opportunity to speak to their position. If the motion passes with two-thirds vote, the minority may speak. If the motion receives a majority vote, but fails to pass for lack of a two-thirds vote, the majority may speak.

Remember that saving "minority opinions" for after the vote, when there is no rebuttal, is a time-waster, for it can force the Conference body to reconsider a question that might well have been decided the first time around if it had been thoroughly examined from all sides.

General Rules of Debate and Voting

(Agreed to at the beginning of each Conference)

- People who wish to speak line up at the microphones and address their comments to the chair.
- Each person may speak for two (2) minutes.
- No one may speak for a second time on a topic until all who wish to have spoken for the first time.
- Full discussion of a recommendation should take place before each vote.
- Everyone is entitled to express his or her opinion. However, if your perspective has already been stated by someone else, it is not necessary to go to the mike and say it again.
- . Our experience is that premature actions such as amend-

ing motions early in the discussion or hastily calling the question can divert attention from the subject at hand, confusing and/or delaying Conference business.

Motions Made During Conference

When making a motion, come to the microphone and address the chair. There are various types of motions we use to help reach an informed group conscience. The specific rules goveming each are on the next page.

Tabling a Motion

Tabling a motion postpones discussion to a later time during the same Conference.

Motion to Recommit

The motion to recommit returns a motion or proposal to the respective trustees' committee or appropriate corporate board for further consideration. A motion to recommit must be seconded is debatable and can be amended.

Calling the Question

Calling the question brings debate to a halt while Conference members decide whether to proceed directly to a vote (the question) or go on with the debate.

Reconsideration

A motion to reconsider a vote may be made only by a member who voted with the prevailing side, but it can be seconded by anyone. If the majority votes to reconsider, full debate, pro and cons. is resumed.

Floor Actions

It is possible for a Conference action to come from the floor, but any matter which falls within the scope of a Conference committee ought first go through that Conference committee, so that the topic may receive due consideration. Floor actions may be introduced at any time during the Conference except at the Sharing Sessions. Any floor action regarding a piece of committee business that has not yet been concluded will be considered out of order. When a floor action is to be heard, its maker will be given two (2) minutes to state the rationale behind the action, after which the chair shall ask if there is a motion that the Conference decline to consider the floor action.

Declining to Consider a Floor Action

A motion to decline to consider a floor action is made without comment.



 - Increased use of technology
 - In 2017 Grapevine asked seated Delegates at the General Service Conference what it might look like if Grapevine had: (1) a podcast; (2) a blog; (3) a social media presence; (4) a revamped aagrapevine.org website; (5) more audio and video content; and (6) increased share-ability
 - Had a goal to bring this to life in time for 2020 International Convention, which was cancelled
 - Shortly thereafter, aagrapevine.org went from below 40,000 visitors a month to over 200,000 a month at its peak

2021 Highlights

- External Audit: "Clean" opinion
- G.S.B. Accounting Surplus of \$1.7M and Cash Surplus of \$53,000
 - Build up of Publications Inventory, which will create cash when sold [322,000]
 - 2021 contributions deposited in 2022 creates cash in 2022 [322,000]
 - G.S.B. Transfer to Reserve Fund in 2021 [250,000]
 - Payment of Deferred Social Security Tax is greater than expensed in 2020 and used cash in 2021 [278,000]
 - Amount owed from Grapevine for shared services purchased in 2021 will create cash in 2022
 - Surplus resulting in 700K+ more than budget due to contributions of 10.7 million versus budget of 10M, savings in key expense categories [775,000], yet higher printing and distribution costs of literature (-542,000)
- Contributions
 - 10.7M in 2021—a new record (it was 10.3M in 2020 and 8.9M in 2019)
 - In 2022, online contributions account for 23% of the total. (In 2012, online contributions accounted for 3%)

Monday 4/25 G.S.B. Finance Presentation (Cont.)

2021 Highlights (Continued)

- Favorable Grapevine/La Vina Results
 - While paid PRINT subscriptions decreased by 11%, ONLINE/MOBILE subscriptions INCREASED by 73%
 - La Vina circulation decreased by 12% (versus a 37% decrease in 2020)
 - Total loss of \$113,000 (versus a loss of \$299,000 in 2020)
- Literature Sales
 - Big drop. Contribution growth has only partially offset the loss from decreased literature sales.
 - Combined gross profit and contributions are running at least \$1M below 2019 levels
- Reserve Fund
 - In 2020 the Reserve Fund was drawn down by \$4M.
 - This was initially due to the cancellation of the 2020 International Convention. Much of that loss was ultimately covered by insurance. However, by that time, literature sales dropped (as explained above). Contributions have offset part of this loss, but not entirely.
 - The General Service Board and the Trustees Finance Committee are taking a cautious approach
 - Transfer of \$250K in 2021
 - · Desire not to put more in the reserve than can be truly be afforded
 - Target range is 9 to 12 months; currently at 7.84 months
- 2022 Budget
 - 2022 budget includes a deficit of 1.35M to be funded from 2021 surplus

Tuesday 4/26 – Agenda Committee Experience Part II

- Committee reviewed surveys from the 2021 G.S.C. and the survey format for the 2022 and made no official recommendations, although the committee secretary noted some suggestions.
- New Business (That's an option, by the way! Committees can raise New Business!)
 - The committee <u>recommended</u> that the General Service Board develop a status report on the progress and outcomes from the 2013-2015 Conference inventory and include a draft plan for another Conference inventory with considerations of its value, timeline and approach to be brought back to the 2023 Conference Committee on Agenda.
- Additional Committee Consideration:
 - The committee expressed appreciation for the special Board presentation related to the participation of online groups in the U.S./Canada service structure at the 72nd General Service Conference. The committee agreed that a sharing session with more time for a broader range of perspectives from among Conference members would be helpful.

The committee requested that the General Service Board conduct an interactive sharing session at the 73rd General Service Conference on the participation of online groups in the U.S./Canada service structure and include the following question within the framework of the sharing session:

• What are the successes and challenges at the group, district and area levels with respect to this topic?

This supersedes the 1997 Advisory Action that designated online groups as "International Correspondence Meetings"
 - (2) The General Service Board form a committee to explore future possibilities for the participation of online groups in the U.S./Canada General Service Structure
- Committee Work So Far
 - Includes: Meeting with the Working Group, Meeting with the Online Intergroup of AA (OIAA), Consulting Other 12 Step Fellowships, Consulting Other Countries/Service Structures, Reviewing Submissions to the G.S.C.
- Note: there currently exists an Application for Additional Delegate Area Form

- Challenges: Experience Gathered from Working Group
 - · Listing Groups in Districts and Areas that the office has not yet been able to communicate with and are still learning

 - International members wanting to be a G.S.R. in the U.S./Canada

- Does not provide voice in the U.S./Canada Conference Structure

 - Overeaters Anonymous has a Virtual Region (since 2018)
- International Experience
 - Ireland has integrated
 - Argentina is looking at ways to integrate
 - Groups are seeking to part of the structure in Brazil

G.S.B. Ad Hoc Committee on Participation of Online Groups in the U.S./Canada Service Structure (Cont.)

What We Have

- G.S.O.'s database has more than **700** active "virtual" groups in the U.S./Canada Structure
 - 450 have a G.S.R.; 140 have an Alternate G.S.R. in addition to a G.S.R.
- Virtual is defined as online and phone groups
- 300 groups in the database need to be contacted regarding their preferred District/Area

What We Know

- Currently, the **highest** number of groups in any given Area is **2,300**
- Currently, the **lowest** number of groups in any given Area is **159**
- The average number of groups per Area is currently **765**
- G.S.O. Group Services Desk reports consistent increase of these Groups since the 2021 G.S.C.

What The Ad Hoc Committee Needs

- Shared experience from local Areas (Area Delegate hopes to arrange for more sharing)
 - How are local Areas/Districts doing with the inclusion of virtual groups?
 - What are the wishes and needs of the virtual groups themselves?
- Reviewed Submissions (not forwarded)

G.S.B. Ad Hoc Committee on Participation of Online Groups in the U.S./Canada Service Structure (Cont.)

- There were 6 Proposed Agenda Items Submitted to the 72nd (2022) General Service Conference pertaining to online or virtual groups
- These Proposed Items were not reviewed by the Conference but were reviewed and presented on by this Ad Hoc Committee
- One of the submissions was sent in by your Area 11 Delegate last Fall: "Consider creating a virtual Area for virtual groups in the United States/Canada General Service Conference structure." Excerpts from the submission were included in the Ad Hoc Committee's Presentation."

Excerpts:

- Hypothetical Scenario 1: A virtual group consists entirely of A.A. members in Connecticut. If the group decides to be listed as a group in Nebraska, even though all of its members live in Connecticut, the 71st G.S.C. Advisory Action indicates that this group would be listed in Nebraska.
- Hypothetical Scenario 2: A virtual group consists of seven A.A. members—six from Connecticut and one from Tennessee. The group makes no preference about which District in Area 11 (Connecticut) to join. The one member from Tennessee serves as the group's primary contact and registers the group with the G.S.O. The group is now registered in Tennessee because the address of the group's primary contact serves as the default location.
- Hypothetical Scenario 3: A virtual group has existed for many years and has thirty members in thirty different Areas. Which District or Area should they join?

Online/Telephone Group Discussion (Cont.)

- Inclusion of online and telephone groups raises many questions
 - How does a new Area usually form?
 - How does a new Area form when it is not separating from an already-existing Area?
 - How do various international service structures differ from the U.S./Canada service structure?
 - What is the value of being registered with the General Service Office as a group and why do group records matter?
 - How does an Intergroup/Central Office differ from an Area?
 - What are the different reasons members belonged to online or telephone groups prior to the Covid-19 pandemic?
 - Should geographic Areas form electronic Districts for online and telephone groups, covering the whole span of the Area—similar to linguistic Districts—or is this approach only preferred by some groups?
 - What are some of the ways that different Areas are autonomous in how they are structured, and how might that be relevant for a virtual Area?
 - What exactly makes an A.A. group an A.A. group, anyway?"

Online/Telephone Group Discussion (Cont.)

- What Your Area 11 Delegate knew as of Tuesday (4/26/22) [Note: some of this information was learned by your Area 11 Delegate from the Ad Hoc Committee Presentation... and some of this information was learned through some additional research and through informal discussions before the Conference.]
 - There is not a one-size-fits all online or telephone group
 - Not all online or telephone groups want the same thing
 - There are online/telephone groups that want to belong to geographic Districts and Areas
 - Some geographic Districts/Areas are prepared and equipped to welcome this and some are not
 - There are online/telephone groups that want to form a non-geographic District within a Geographic Area
 - Two virtual Districts have been formed—one in Area 48 and one in Area 72
 - There are online/telephone groups want to form one or more non-geographic Areas
 - There are over 700 online and/or telephone groups registered with the G.S.O.
 - This number is consistently growing since the 2021 General Service Conference
 - The average Area has 735 groups

WHAT IS A FLOOR ACTION????

What is a Floor Action?

•It is what happens when someone starts breakdancing at the General Service Conference

- The previous slide was just a joke—don't worry. Unfortunately, there was no breakdancing...
- Simply put: any Conference member may submit a floor action as a way to discuss a piece of business that would not otherwise be discussed and voted on by the Conference that year.
- "It is possible for a Conference action to come from the floor, but any matter which falls within the scope of a Conference committee ought first go through that Conference committee, so that the topic may receive due consideration. Floor actions may be introduced at any time during the Conference except at the Sharing Sessions. Any floor action regarding a piece of committee business that has not yet been concluded will be considered out of order. When a floor action is to be heard, its maker will be given two (2) minutes to state the rationale behind the action, after which the chair shall ask if there is a motion that the Conference decline to consider the floor action."—From "How the Conference Operates
- Your Area 11 Delegate considered submitting a floor action pertaining to creating an Area for online/telephone groups—but waited to see the Policy & Admissions Report first.

Virtual Groups in Area 11

- At least 20 virtual groups in Area 11 registered with G.S.O. so far—with more pending—as of this presentation
- Area 11 Delegate hopes to reach out gather sharing from all of them soon
 - How are things going?



- Answer: in the event that you have a decimal, you always round up to the next full number.
 - 1997 Conference Advisory Action (Conference Committee on Trustees)
 - In the election of regional or at-large trustees, when the number to determine 1/5, 1/3, or 2/3 is a fraction, the next higher whole number will be used.
 - 1998 Conference Advisory Action (Conference Committee on Policy and Admissions)
 - When calculating the number of votes to determine substantial unanimity or a 2/3 majority on the Conference floor, when the number is a fraction, the next higher whole number will be used.

Literature Advisory Actions

• It was <u>recommended</u> that:

The pamphlet "Questions and Answers on Sponsorship" be revised to add the following text regarding safety and A.A.:

- 1. In the section "For the person wanting to be a sponsor" (p. 14) under the heading "What does a sponsor do and not do?": Stresses the importance of A.A. being a safe place for all members and encourages members to become familiar with service material available from the General Service Office such as "Safety in A.A. Our Common Welfare."
- 2. In the section "for groups planning sponsorship activity" (p.23), under the heading "How does sponsorship help a group?" add a fourth paragraph: Sponsorship can also help a group to create a welcoming and secure environment. Safety is an issue affecting all members and it is important for groups to remain accessible to all who are seeking recovery. Sponsorship can help keep the group focused on common welfare.

• It was <u>recommended</u> that:

The booklet Living Sober be revised to add the following paragraph regarding safety and A.A. in chapter 29, page 76: "Of course, A.A. is a reflection of the larger society around us and problems found in the outside world can also make their way into the rooms of A.A. But by keeping the focus on our common welfare and primary purpose, groups can help provide a safe and secure environment for all their members."

• It was <u>recommended</u> that:

The video animation of the pamphlet "The Twelve Concepts Illustrated" (currently published by the General Service Board of A.A. Great Britain) be adapted and produced by the Publishing Department. The committee requested a progress report or rough cut be brought back to the 2023 Conference Committee on Literature.

• It was <u>recommended</u> that:

• The draft of the pamphlet "Young People and A.A." be approved."

- Challenges and successes with quarantine
- Challenges and successes with continuing to remain a part of the Conference Process
 - Reached out to 72nd G.S.C. Policy and Admissions Committee Chair
 - Advocated for a way to participate remotely from hotel room
 - Audio/observation only—no ability to vote or otherwise participate from my room
 - Persistence > was able to submit a floor action from my hotel room (with help from another Delegate)
 - Got patched in for a two-minute "farewell;" used this opportunity to speak to concern about G.S.O. bus trip
- Aftermath (including more positive cases)
- Spiritual Takeaways/Positives
 - Gratitude for fellow Conference members reaching out to me
 - More lessons on the importance of not people-pleasing and of being willing to speak up
 - Helped others that tested positive after me
 - Disappointment over contingency planning/preparation→ a big lesson in acceptance (especially floor action)
 - Area 11 Delegate sent a Memo to the three Board Chairs, GM, Conference Coordinator, and all 72nd G.S.C. (for the future—not about me)

 As far the English Big Book translation into plain and simple language continues—either a progress report (progress to continue) or a draft will be brought back to the 2023 Conference Committee on Literature.
 - As far as requests for workbooks and study guides to accompany the Big Book and the book Twelve Steps and Twelve Traditions, the committee noted a need for additional information. The committee requested that the Trustees' Literature Committee provide further information regarding the purpose of such proposals and examples of what such guides might look like (for exploration).
 - **Heavily Discussed at Area 11 Pre-Conference Assembly
 Regarding the changes to the book Twelve Steps and Twelve Traditions as a result of the 71st (2021)
 General Service Conference, the committee noted that there does not appear to be a consensus on the changes among A.A. members at the local level.

Finance Committee



A. These online gatherings are not streamed to the general public; however, information about the meeting is provided to A.A. members, potential members, and the general public similar to inperson meetings.

While some members feel comfortable using their full names and faces other members feel it is more aligned with Tradition 11 to use only their first name and last initial or turning their camera off. For safety purposes some groups have provided helpful reminders in their group format that picture-taking or screen shots are not in keeping with anonymity principles.

 - Committee appreciates the work the Trustees Public Information Committee on the Comprehensive Media Plan (with some suggestions for improvement noted)
 - Suggested updating the A.A. World Services YouTube Channel more regularly and adding more Spanish content
 - The committee encouraged developing an annual project calendar relating to Google Ads. The committee noted that the office should continuously optimize the Google Ads campaigns based on standard best practices in keeping with A.A. Traditions focusing on target audiences utilizing A.A. literature we currently have and that may be developed.
 - Noticed the improvement to aa.org, while suggesting search engine optimization
 - (Grapevine has a podcast)—Overall positive response to the Grapevine podcast—however, it was noted that the hosts may consider attraction to all members, potential members, or professionals and to consider the full intended audience regarding diversity, attraction, and belonging.
 - The committee appreciated the research on paid placement of PSAs on streaming platforms, encouraged further research by the Trustees Committee on Public Information, and to bring a progress report to next year's Conference.
 - Reviewed the progress report on the G.S.O. podcast plan and suggested moving forward, using the Grapevine podcast while focusing on different topics in order to avoid competition with the Grapevine podcast. Suggested entrusting the G.S.O. to manage the podcast's creation and adherence to A.A. principles.

Public Information Highlights from Additional Committee Considerations (Cont.)

- Continued (Partial List and Paraphrased)
 - Additional revisions were suggested for the pamphlet "Speaking at Non-A.A. Meetings," asking that a progress report or draft pamphlet be brought back to next year's Conference.
 - Suggested further revision to "A.A. at a Glance," such as modernizing the look, removing the phrase "hopeless drunks" to focus more on the solution, and updating the self-support language (to remove any reference to a certain dollar amount).
 - **Note: it is good to remember that there is a difference between an inward-facing pamphlet and an outward-facing pamphlet
 - **Heavily Discussed at the Area 11 Pre-Conference Assembly
 - The committee considered the request to create a new form of communication to address anonymity on social media by reviewing a draft survey developed to gather shared experience from the Fellowship. The committee requested the trustees' Public Information Committee and staff secretary focus on distributing the survey, to all age demographics, particularly a young population, and obtain results that will inform decisions on any future new form of communication. The committee looks forward to a progress report to be brought back to the 2023 Conference Committee on Public Information.

Conference Committee on Trustees

 - The report of the trustees' Nominating Committee noted they had begun discussion of thread-based forums and that more discussion is needed. The Conference committee had a discussion on thread-based forums which could allow better communication throughout the Conference structure and is forwarding a summary of their suggestions to the trustees' Nominating Committee.

 - The committee discussed the impact of the Preamble change from the previous year and noted it is premature to quantify such impact as there are many members that are uninformed or ambivalent about the change. The committee emphasized that at every level of our Conference process there is a reciprocal responsibility of all A.A. members and trusted servants, of participation and communication, to embrace the guiding principles of trust and transparency

The committee also noted the workflow, communication, and scoring tool challenges, as well as the significant challenges to areas and to the group conscience process caused by moving up the deadline for submitting proposed agenda items to September 15. The committee hopes that whatever can be done to address these challenges will be done over the next two years of the pilot.
 - The committee reviewed with appreciation the progress report on the development of a process using virtual meeting technologies for polling the General Service Conference between meetings and looks forward to development of the process.
 - **Heavily Discussed at Area 11 Pre-Conference Assembly
 (Equitable Distribution of Workload Items). The committee considered the request to revise the pamphlet "Questions and Answers on Sponsorship" to reflect shared experience on service sponsorship and took no action. The committee felt that the topic of service sponsorship is already addressed well in the current version of the pamphlet "Questions and Answers on Sponsorship" and in the current A.A. Service Manual/Twelve Concepts for World Services.

Report and Charter Advisory Actions

• It was recommended that:

Chapters 8, 9, 10, 11 and 12 of The A.A. Service Manual be revised to correct inaccuracies and to provide clarity and consistency on the roles, responsibilities and relationships between the General Service Office, AA Grapevine and A.A. World Services, Inc. (Note: Because 2023 is a printing year these changes would be reviewed by the A.A.W.S. Board, AA Grapevine Board and the General Service Board prior to being brought to the Conference Committee on Report and Charter. This process is in keeping with the 2018 advisory action regarding review of The A.A. Service Manual Combined with Twelve Concepts for World Service.)

• It was <u>recommended</u> that:

Items 5 and 6 that relate to Regional Directories be removed from the Scope of the Report and Charter Composition, Scope and Procedure. (Note: Regional Directories are no longer being produced.)

Report and Charter Additional Committee Considerations

 - **Heavily Discussed at the Area 11 Pre-Conference Assembly
 The committee discussed the request that the chapter titled "The Doctor's Opinion" be returned to page one, as it was in the First Edition of the book Alcoholics Anonymous and took no action. The committee noted that Bill W. was involved in the repagination of Alcoholics Anonymous for the second edition. It was also noted that such a change would impact other pieces of A.A. literature that reference pages in the book Alcoholics Anonymous. The committee added that they did not recognize a strong "spiritual need" to revert to the original pagination. (Equitable distribution of workload item.)
 - The committee discussed the request to include the GSR preamble in the pamphlet "GSR: Your Group's Link to A.A. as a Whole" and took no action. The committee agreed that the GSR pamphlet adequately describes the role and purpose of a GSR. The committee agreed that this statement is better left to local group autonomy. (Equitable distribution of workload item.)
 - The committee discussed General Service Conference reports and noted: (a) appreciation for digital distribution, (b) Delegates should be encouraged to give reports in innovative and creative ways (utilizing technology, such as an anonymity-protected video), (c) Fellowship Connection can be used as a tool (Thank You letter with a link to Final Report)

Report and Charter Additional Committee Considerations (Continued)

- More Noteworthy Additional Committee Considerations (Partial List and Paraphrased)
 - The committee reaffirmed the 2021 advisory action that "A new section be added at the end of the Twelve Concepts for World Service titled 'Amendments,' and that it contain an updated version of the Concept XI essay that incorporates the information in the current footnotes and endnotes, along with comprehensive descriptions of the current General Service Board committees." The committee requested that the staff secretary work with A.A.W.S. Publishing on a draft update of the section to be brought back to the 2023 Conference Committee on Report and Charter.
 - The committee requested the print listing of Central Offices, Intergroups and Answering Services for the United States and Canada (Item F-25) be retired, in light of the cost. Cooperation with local service structures along with data stewardship can help accomplish the same goals.
 - The committee requested that the A.A.W.S. Board research the need for and feasibility of a translation of The A.A. Service Manual Combined with the Twelve Concepts for World Service into ASL and asks that a report be brought to the 2023 Conference Committee on Report and Charter. In addition, the committee encourages local areas, districts, and Intergroups/Central Offices to make ASL interpretation and service opportunities more accessible to the Deaf community
 - The committee noted that The A.A. Service Manual can be utilized for all individuals involved in the General Service structure. The text is not limited to new people in service or only GSRs. Class A trustees, appointed committee members, non-trustee directors and other roles in general service should be able to draw upon the experience shared in specific chapters

Treatment and Accessibilities

Advisory Action

The Long Form of Tradition Five be added to the pamphlet "The A.A. Group" on page 12 in the section "What is an A.A. Group?" at its next printing.

Note: As a result of the 2021-22 Equitable Distribution of Workload plan, this item was on the agenda of the Conference Committee on Treatment and Accessibilities

The committee noted that the section includes this comment later in the chapter: "If the condition persists, it may be advisable to check with a good physician who understands alcoholism well."

 The committee discussed the request to reconsider use of the term "person in custody" in A.A. literature and took no action. The committee affirmed the need for language that is inclusive and non-stigmatizing, as expressed by the 71st General Service Conference. The committee also discussed that implementation of the advisory action was already in place and that it would be premature at this time to reconsider the action.
 - The committee noted the increased use of online A.A meetings in correctional facilities and suggested that G.S.O. staff gather shared experience regarding online meetings in correctional facilities for addition to the Corrections Workbook
 - The committee discussed the request to limit changes to the book Alcoholics Anonymous and took no action. While the committee discussed the concerns expressed by the Fellowship, the committee noted that we operate on a system of trust and checks and balances, and agreed that A.A.'s Twelve Concepts adequately provide guidance to our trusted servants to make decisions that reflect the informed group conscience of the Fellowship as a whole.
 - The committee suggested that during the development of the 5th Edition Big Book the trustees' Literature Committee consider including a reference in the section of Appendices III and IV that additional information is available on www.aa.org
 - The committee discussed the request to make A.A. literature changes slowly and with A.A.'s primary purpose in mind and took no action. The committee agreed the cadence and role of the annual General Service Conference already provides the appropriate guidance. The committee also noted that through Concept Four, "The Right of Participation," all members of Alcoholics Anonymous are invited to participate in the year-long process of the General Service Conference

 - New shared experiences and a new subsection from local archivists on specific topics pertaining to archival work;
 - Revised Guidelines for Collecting Oral Histories to include text offering suggestions on ways to conduct ASL interviews with members in the Deaf community to offer a wider diversity of sharing;
 - Replaced gender-specific language throughout the workbook;
 - Updated Archives policies; and other minor editorial updates.

It was recommended that:

With the translation of the book *Alcoholics Anonymous* (Fourth Edition) into plain and simple language, that the Twelve Steps, the Twelve Traditions, and the Twelve Concepts, not be translated into plain language in any way: that these remain in the existing form in English as in previous editions of the book *Alcoholics Anonymous*.

Declined to be considered (and thus it did not pass)

Floor Action #2

It was recommended that:

The trustees' Committee on Literature continue to make edits to the draft pamphlet "The Twelve Steps Illustrated" with a new draft or progress report to be brought back to the 2023 Conference Committee on Literature, keeping in mind: color, diverse expressions of spirituality and accessible interpretation of meaning in the illustrations.

Considered, discussed, and passed.

Floor Action #3

It was recommended that:

The 2022 Membership Survey questionnaire receive final editorial review by the trustees' Public Information Committee after consulting with our professional survey methodologist, to address concerns raised by the 72nd General Service Conference related to the survey questions about Racial and Ethnic Background, and Employment Status.

Considered, discussed, and passed.

• Floor Action #4

It was recommended that:

The General Service Conference impose a one-year moratorium on any new agenda item received through September 15, 2022, with new agenda items held to be placed on the agenda for the 74th General Service Conference, allowing the General Service Board and its corporate affiliates time to adjust and align their processes to accommodate the 2022 Policy and Admissions recommendation to provide simultaneous translation of all background material.

Declined to be considered (and thus it did not pass)

Floor Action # 5

• Submitted by Area 11 Delegate

It was recommended that:

The trustees' Ad Hoc Committee on Participation of Online Groups develop a plan to create one or more non-geographic Areas for online and telephone groups in the U.S./Canada General Service Conference structure, with a progress report on the plan to be presented to the 73rd General Service Conference Committee on Policy and Admissions.

While this was considered and discussed, it did not pass when it came to a vote.

Floor Actions (Continued)

• Floor Action #6

It was recommended that:

That the [...] GSR Preamble [included in the 72nd G.S.C. background material] be added to the pamphlet "Your Group's Link to A.A. as a Whole."

Declined to be considered (and thus it did not pass)

• Floor Action #7

It was recommended that:

The trustees' Committee on the General Service Conference evaluate the current process of developing Conference background material and bring back to the 2023 General Service Conference Committee on Policy/Admissions a plan that describes the process of developing background material, keeping in mind the Conference desire for background material to be targeted, balanced and with relevant historical content.

While this was considered and discussed, it did not pass when it came to a vote

• Floor Action #8

It was recommended that:

The Advisory Actions from Panel 71 [...] [pertaining to the changes] in the book Twelve Steps and Twelve Traditions, be returned to the original text.

Declined to be considered (and thus it did not pass)

Floor Actions (Continued)

• Floor Action #9

It was recommended that:

The 1995 Conference Advisory Action be affirmed that the first 164 pages of the Big Book, the Forewords, "The Doctor's Opinion," "Doctor Bob's Nightmare" and the Appendices remain as is.

While this was considered and discussed, it did not pass when it came to a vote
