Area 11 General Service Committee

What an amazing experience I had at the Area 11 Spring Assembly this year! Thank you so much to those of you who came out to hear my report-back from the 73rd General Service Conference! It was a long day and my voice was ready for a break by the end but the interest in AA service and the interaction with attendees makes all this hard work that much easier! Prior to the 73rd General Service Conference, all members of the Conference, including Delegates, Trustees, Non-Trustee Directors and GSO staff, met for a third and final Q&A session related to the General Service Board Resignations and the events leading to them. This session was an emotional one in which there was sharing from many of the people directly involved and impacted by these events. This was an opportunity to begin a path of healing and corrective actions that I feel continued through the General Service Conference and, in fact, helped to shape the tone and outcomes of the Conference week. I have updated my timeline of events related to this and you can read through it here. I have included all related communications and documents, as well.

Although the weeklong General Service Conference is over, the work of the Conference continues all year long! Now that we have gotten through the business on the agenda, it is the job of the Delegate to continue ensuring that all information gets passed on to the members of the Fellowship and the lines of communication remain open. Advisory Actions and Committee

Considerations: Many of the discussions and recommendations during the Conference centered on improving trust and communication in the service structure. Advisory Actions that were passed with substantial unanimity included a formal inventory of the General Service Board to be performed prior to the 74th General Service Conference, an inventory of the entire General Service Conference to take place during the 75th Conference week, the initiation of general sharing sessions with participation by all members of the Conference outside the annual week-long meeting and others. General Service Board Updates

Opening for Non-trustee Appointed Committee Member for Trustees' Committee on Literature:

In keeping with the recommendation of the 2021 General Service Conference that "a Fourth Edition of the Spanish-language Big Book, *Alcohólicos Anónimos* (Spanish) be developed," the trustees' Literature committee see the need to initiate the search for an ACM that will continue to serve as leader of the Working group for the development of a draft Fourth Edition of the book, *Alcohólicos Anónimos*.

Some of the qualities most desirable for this non-trustee opening are:

- Expertise in and/or familiarity with the use of current technology and communications tools.
- Available time to attend meetings of the trustees' committee to which appointed, the Saturday afternoon general sharing session at Board Weekends, the joint committee meeting on Sunday Afternoon at the General Service Conference, participation in subcommittees of the committee to which appointed (which may include conference calls). Additional meetings/dinners at which attendance is optional.
- At least 5 years of continuous sobriety.
- The ability to work within the committee structure.
- Experience in AA service and in carrying the message to the Spanish-speaking alcoholic (bilingual preferred).

Appointed committee members are appointed for one year but the term may be extended, depending on committee projects (maximum of 4 years).
