Area 11 General Service Committee

Over the past few years, communication has been a common theme throughout my journey in Alcoholics Anonymous. It has come up in my step work, in group inventories, and was a very prominent topic of discussion at the General Service Conference last spring. In my experience, clear and effective communication must be the basis for every relationship, whether it be personal, business, or service-related. It lays a foundation of trust, understanding, and cooperation. It helps to define clear goals and the path to achieve them. It serves to provide checks and balances.

Communication can take on many forms and appearances. It can be delivered in a multitude of ways. The methods of delivery continue to evolve and information swirls around us at speeds that were unimaginable years ago. But still, we struggle to keep this communication clear and effective.

At the level of the General Service Conference, it is a topic that is discussed frequently. How do we keep the Fellowship well-informed? What is the method for collecting information from the Fellowship? Is the Conference structure still effective? How do we utilize new technology while also making sure we meet the needs of those who lack accessibility? These are just a few of the many questions and topics about communication within the Fellowship that come up regularly. Very important discussions that must continue for the health and growth of the Fellowship.

much discussion about how to restore faith and trust at the very bottom of the upside-down triangle. Many of the responses have included words like "communication" and "transparency". Also, requests for additional or simplified reporting, particularly around finance have been heavily suggested. There were many Advisory Actions and Committee Considerations from the 73rd GSC that were the result of these discussions and the desire of the Fellowship to "right the ship".

One Committee Consideration that came out of the Conference Committee on Public Information was to design a pilot study to utilize our existing technology platforms (Meeting Guide App and A.A. Website) to perform membership surveys through "convenience" sampling. This pilot study was recently performed and hopefully, many of you got the opportunity to participate. While the study saw good engagement, the process was not without its flaws, most of which came back to poor communication. The Delegates were able to provide feedback about the frustration with this process at our November Sharing Session, which was good timing and will hopefully be helpful for projects such as this in the

Another Committee Consideration from the 73rd GSC came from the Conference Committee on Finance. It was a request that the Trustees' Literature Committee seek input from the Fellowship regarding any possible future changes to literature written by A.A.'s founders. Recently, the Delegates received a communication from the Trustees' Literature Committee with a plan to gather shared experience from the Fellowship on this topic. This information is to be gathered through sharing and discussion at the local level and brought with the Delegates to the 74th GSC for a sharing session on this topic to take place during Conference week. I will be putting together some information to guide these discussions at the group and district levels so that it can be a part of the Over the course of the past year, there has been pre-conference process. I look to the membership of Area 11 to provide me with the informed group conscience so that I may actively participate as the voice of the Area at that sharing session.
