Officer Reports

- Secretary (Laura M) Roll call: 7 out of 10 GSRs present. Motion made by Guy to accept the minutes from July 25th, JonWayne seconded. Vote to accept: unanimous
- DCM (Patrick K) Patrick will discuss his report in Old/New business
- Alternate DCM (AI R) Al read the treasurer's report in Nicole's absence. Motion made by Guy to accept the report, seconded by Joe. Vote to accept: unanimous. Al attended the sharing session on the Answering Service. A GSR asked if we had a list of names and what districts are in need? Yes a list has been compiled and yes, a need still exists in all districts for volunteers. A GSR asked if the volunteers needed to be from the town or meeting to volunteer? EX: a member of a group in Preston can only respond to calls from that town. No. A GSR asked what the official name of this service is. Area 11 Answering Service. A GSR asked if we had a chair in District 31. This will be addressed in Old Business.

Committee Reports

- Website (Brian) The roles and duties will be presented in September. A site chair will be voted in September/October. Area 11 will not be printing meeting schedule pamphlets anymore, districts will have to do this on their own.
- CSCYPAA (Jake & Eva) Jake has registered for the event and will be reimbursed by the treasurer. There is an open event being held at Harkness Park on August 24th from 1PM-5PM that is oriented towards CSCYPAA.
- Treatments (Toby) Toby Absent. Patrick reported on his behalf that Toby attended the Area 11 Treatments Zoom meeting.

Old Business

- Answering Service Election Joe B stated that his father was very interested in this position and would be willing to stand (not present due to family obligations). The vote has been tabled until the next district meeting. Updated volunteer lists are needed by 8/23.
- Area 11 Convention attendance vote for DCM MOTION: The allowance of reallocation of funds to cover the cost of the DCM to attend the Area 11 65th Annual Convention. Costs include hotel for 2 nights (approximately \$302), registration, and mileage to and from. Round table: Step by Step approved mileage and registration but not the hotel costs. As Bill Sees it decided if it was required for the DCM to attend they would vote yes. As per the guidelines it is not required but "suggested" that the DCM attend. SNL voted no based on the hotel costs as the convention is in-state and within reasonable driving distances. Sober on 164 voted yes. Further discussion was held and the guidelines were reviewed. The VOTE was called and the results were 6:1 in favor of reallocating funds to cover all costs of the DCM's attendance. MOTION PASSED.
- Alcathon vote District 1 has already voted on a Halloween Alkathon but the details are still unclear. MOTION: Would District 31 assist District 1 with a holiday Alkathon? Round table: Step by Step showed no interest. Helping Hands noted that District 1 is very active and this would help inclusion. The VOTE was called: 2 Yes, 4 No, 1 Abstain. Minority allowed to discuss. Concern over organization and participation was discussed and a re-vote held. VOTE: 3 yes, 4 no, MOTION DOES NOT PASS.
- Guidelines approval for Alt-DCM, Treasurer, & Secretary Due to time constraints

this was moved to New Business.

New Business

- District 31 Website posting approval MOTION: Grant the District 31 officers the right to post fliers concerning group announcements, minutes, agenda, treasurer's reports, etc to the District 31 website without GSR prior approval. Round table: The webchair must follow Area 11 web posting guidelines. It was mentioned by a GSR that waiting to post information could reduce/delay the spread of pertinent information. A GSR asked if this could be shelved due to time constraints. MOTION: Shelve the aforementioned posting approval vote until the next business meeting. VOTE: 6 yes, 1 no, MOTION PASSED.
- Open Position Interest **Moved to next business meeting.**
- Guidelines approval for Alt DCM, Treasurer, Registrar, Recording Secretary (moved from Old Business). <u>Moved to the next business meeting.</u>
