Officer Reports

- Secretary (Laura M) Roll call: 5/10 GSRs present, the majority reached. Amendments were made to the October minutes to more accurately reflect the discussion. John made the MOTION to approve the minutes, Joe seconded, and the minutes were accepted with amendments.
- Treasurer (Nicole B) Presented the November treasurer's report. Jonathan made a MOTION to approve the treasurer's report, John seconded and the motion was passed unanimously. Discussed the budget proposal meeting and finance review meeting. The finance review committee will meet on December 19th at 5:30 pm, before the GSR meeting. The GSR that had previously volunteered to be on the finance review committee has not attended the past two GSR meetings and as such the DCM asked for a volunteer to take his place. JonWayne volunteered. A question was asked regarding how many GSRs are required to attend the budget proposal meeting. A GSR stated that 3 sub-district GSRs from old District 1 attended and suggested 2 GSRs attend the District 31 meeting. There will be a Zoom Treasurer's workshop held on December 4th with new and seasoned treasurers to discuss budgets etc. The DCM suggested a

service workshop to be held on a Saturday in January to review guidelines, hold the 2025 budget committee, and any unfinished business. This was met with widespread approval. The treasurer requested the ability to use monies from her budget to cover the registration fee for the upcoming CSCYPAA event. MOTION to approve the treasurer's use of their budget to purchase a ticket was made and approved.

- Alt-DCM (Al R) Al summarized the thank you e-mail from the GSO. Earlier in the year the GSO had asked for increased donations and the groups responded to this request. Year-to-date contributions increased by 9%.
- DCM (Patrick K) Apologized for the miscommunications that occurred at last month's GSR meeting.

Committee Reports

- Website (Brian) Attending Area 11 web committee meetings. There are not a lot of districts being represented and therefore not a lot going onto individual district websites. He made note of District 20 (www.d20a11.org) and how well the website is structured and the features it offers. Questions: Is Area 11 looking to reconfigure/acclimate the website? Yes. Will we be staying on the Area 11 page or creating a new one? Not yet-It's too soon to consider. Can the District 31 GSRs monthly meetings be added to the Service Calendar? Yes.
- CSCYPAA (Jake & Eva) Jake was absent. Eva was absent, excused. She sent notes to the DCM. Pre-registration for this event is encouraged. The bulk of the meetings will be held on Saturday. CSCYPAA 40 will be forming the 2025 committee in January.
- Treatments (Toby) Met with Guy and a Treatment chair committee is in the works so that the treatment chairs from the districts can meet to discuss relevant topics. He presented a literature order and the treasurer will write a check to ECTI. Had questions regarding the budget and when it will be reset. The budget will reset back to \$200 (or another TBD amount) on February 1st.
- Answering Service (Joe B) Submitted the volunteer list to Area 11 Answering Service Chair to post. The district is still looking for volunteers and the goal is to have a woman and man from each town/city in the district.
