Officer Reports

• Secretary (Laura M) Roll call: 8 out of 10 GSRs present (quorum met) Brought attention to the Delegate's report included in the meeting packet. Motion to accept, unanimous

• Treasurer (Nicole B) Reviewed monthly budget income and expenses. A GSR asked about the amount reimbursed to the DCM (502.37). Nicole broke down the amount into hotel, registration, and mileage. Motion to accept, unanimous.

• Alternate DCM (AI R) Attended the 9/5 answering service meeting. It was suggested that the usual disbursement of 30 to district, 30 to Area 11 and 40 to GSO be adjusted to provide more for Area 11 to cover the cost of the answering service. A GSR asked if they could donate more to the district who could then in turn donate to Area. Answer: no, as those budgets are separate.

• DCM (Patrick K) Patrick was absent due to illness. Al reported briefly on the Area 11 inventory.

Committee Reports

• Website (Brian) Attended the meeting on the 17th to review roles and guidelines. There will be a formal vote on Tuesday. There will be a 3rd party tech support entity to lessen the burden on committee members. The website will be revamped and modernized. Officer positions will be voted on in October. A GSR asked what platform the website was hosted on. Answer: Wordpress and GoDaddy.

• CSCYPAA (Jake & Eva) Jake has registered. Nicole asked if there were monthly meetings Jake could attend as part of his duties.

• Treatments (Toby) Has been attending Area 11 Sunday night Zoom meetings. Had questions about the process of procuring and distributing literature requested by group members. Questions included: who pays? How does the literature get distributed and to where, by whom? Treatments has a budget and should be provided the Treatments handbook.
