Officer Reports

- Secretary (Laura M) secretaryd31a11@gmail.com Roll call was taken. % of registered GSRs in attendance, quorum met. Joe made the MOTION to approve, and Jake seconded. Secretary minutes from December were accepted unanimously.
- Treasurer (Nicole B) treasurerd31a11@gmail.com Online bill pay from the District account is active. The budget is balanced. A member informed the group that the state mileage reimbursement is now \$0.75 per mile. Jonathan made the MOTION to approve, and Jake seconded. Treasurer's report from December was unanimously accepted.
- Alt-DCM (Al R) altdcmd31a11@gmail.com Nothing to report at this time.
- DCM (Patrick K) dcmd31a11@gmail.com Attended the Area 11 Zoom monthly meeting. Plain Language Big Book is still back-ordered. NERAASA (Northeast Regional AA Service Assembly) online registration is still open. There is one vacancy on the Area 11 committee board = CPC (Cooperation with the Professional Community) chair. Attended the ECTI (Eastern CT Intergroup) Zoom presentation. As of February 1st, 2025, the ECTI will disband unless the groups in districts 1, 31, 32, 33, 34, and 35 vote to keep it active. To this end, Patrick asked the GSRs to return to their groups and vote to keep the ECTI active (Yea or Nay vote).

Committee Reports

Website (Brian) Area 11 committee positions are mostly filled. An ad hoc committee was formed to redesign the website. There is a 3rd party tech support vendor. Domain name research research 1year= \$14.99; 5 years = \$34.99. He averaged a cost to the district of about \$164 for 8 district e-mails. With the domain names, the district would have control over the e-mail accounts of the officers and any others added. This would prevent misuse of an e-mail account by an outgoing member.

- CSCYPAA (Jake & Eva): Eva is no longer a GSR or CSCYPAA representative. Jake did not attend the 'wrap-up' CSCYPAA meeting and was asked to attend the monthly meetings. Jake will remain the representative for District 31 until an election is held or the guidelines are finalized.
- Treatments (Toby) **Toby is working on a presentation to Trails Corner in Groton.** He will be touring the facility, and Patrick asked him to coordinate this tour with the officers so they can attend.
- Answering Service (Joe B) Joe attended the Area 11 meeting to work on the Answering Service guidelines. Six new volunteers have been added to the District 31 volunteer list.
